#### **DESCRIPTION:**

ONGOING CHANGES IN CULTURE (E.G., SOCIAL MEDIA, AI) AND MENTAL PRACTICE (E.G., TELEMENTAL HEALTH, MANAGED CARE) HAVE OFFERED NEW ETHICAL CHALLENGES FOR MENTAL HEALTH PROVIDERS.

USING CASE EXAMPLES, DISCUSSION, AND LECTURE, PARTICIPANTS IN THIS WORKSHOP WILL CONSIDER HOW THEIR ETHICAL CODES RELATE TO NEW ISSUES AND CHALLENGES OF THE AGE.

SPECIAL EMPHASIS WILL BE PLACED ON DEVELOPING PROFESSIONALS' UNDERSTANDING OF DECISION-MAKING PROCESSES USED IN ARRIVING AT ETHICAL COURSES OF ACTION IN THE CONTEXT OF THESE CHANGES.

THE WORKSHOP WILL HIGHLIGHT ISSUES OF INFORMED CONSENT, COMPETENCE, CONFIDENTIALITY, AND BOUNDARIES/MULTIPLE RELATIONSHIPS.

#### OBJECTIVES: AFTER THE WORKSHOP, PARTICIPANTS WILL BE ABLE TO:

- APPLY THE ETHICAL CONSTRUCT OF INFORMED CONSENT ACROSS A VARIETY OF MENTAL HEALTH SETTINGS.
- APPLY THE ETHICAL CONSTRUCT OF COMPETENCE ACROSS A VARIETY OF MENTAL HEALTH SETTINGS.
- APPLY THE ETHICAL CONSTRUCT OF CONFIDENTIALITY ACROSS A VARIETY OF MENTAL HEALTH SETTINGS.
- APPLY THE ETHICAL CONSTRUCT OF MULTIPLE RELATIONSHIPS ACROSS A VARIETY OF MENTAL HEALTH SETTINGS.
- ARTICULATE THE ADDITIONAL CHALLENGES TO THESE ETHICAL CONSTRUCTS BY CHANGES IN THE CULTURE AND PRACTICE.
- APPLY A THERAPY ETHICAL DECISION-MAKING MODEL TO A VARIETY OF ETHICAL DILEMMAS.
